VACCINATION VERIFICATION PROGRAM FOR FEEDER CALVES

REQUIREMENTS

OPTION 1 CERTIFIED MAC-VAC

One round of required vaccinations

- Steers and heifers (no bulls)
- **ONE** Respiratory Modified-Live Viral (MLV) vaccine for IBR-BVD-P13-BRSV
- **ONE** Pasteurella (mannheimia haemolytica), can be given in combo with MLV
- **ONE** 7-way Clostridial/blackleg vaccine
- **ONE** Parasite control/dewormer
- Polled or horns less than 2 inches

**Vaccinations must be given 21-90 days prior to being sold*

OPTION 2 CERTIFIED MAC-VAC PLUS

Two rounds of required vaccinations

- Steers and heifers (no bulls)
- **TWO** Respiratory Modified-Live Viral (MLV) vaccines for IBR-BVD-P13-BRSV
- **ONE** Pasteurella (mannheimia haemolytica), can be given in combo with MLV
- **TWO** 7-way Clostridial/blackleg vaccines
- At least **ONE** Parasite control/dewormer
- Polled or horns less than 2 inches

**Vaccinations must be given 21-90 days prior to being sold*

OPTION 3 CERTIFIED WEANED MAC-VAC PLUS

Two rounds of required vaccinations and weaned for 45+ days

- Steers and heifers (no bulls)
- **TWO** Respiratory Modified-Live Viral (MLV) vaccines for IBR-BVD-P13-BRSV
- **ONE** Pasteurella (mannheimia haemolytica), can be given in combo with MLV
- **TWO** 7-way Clostridial/blackleg vaccines
- At least **ONE** Parasite control/dewormer
- Polled or horns less than 2 inches
- Weaned for at least 45+ days
 - 60+ days recommended

**Vaccinations must be given 21-90 days prior to being sold*

ADDITIONAL RECOMMENDATIONS

- Mineral program
 - Bunk broke
- Cow vaccination program
- Bring calves that can be sold in uniform groups

While these are our recommendations, we encourage you to consult your veterinarian regarding herd health management decisions. Always read and administer vaccines according to label directions and use BQA best handling practices.

TAGGING

MAC-VAC ear tags are required to sell during the MAC-VAC portion of the weekly sale. Tags are \$0.50 each and can be purchased in the office.

SALE DAYS

Calves can be sold on any Monday or Wednesday at our participating markets. Bring your completed Health Form with the cattle at drop off. They will sell during the first part of the feeder calf sale each week.
